

PRIVACY POLICY

Effective As of: June 1, 2017

This Privacy Policy (the "Privacy Policy") applies when you access, visit or use the websites owned by Digital Marine Solutions Holding AS ("DMS") and operated through its subsidiaries, including but not limited to C-MAP Norway AS, C-MAP USA Inc., C-MAP Australia Pty. Ltd., C-MAP Poland SP.z.o.o., C-MAP Italy S.r.l., C-MAP India Private Limited, C-MAP Greece MEPE, C-MAP Japan K.K., C-MAP Germany GmBh, and Cruise L.I.c. (the "Company," "we," "us" or "our") located at gofreemarine.com, GenesisMaps.com, BioBaseMaps.com, gofreeshop.com (collectively, the "Sites" or "GoFreeShop") or use any of the products and services including but not limited to any products and services that we offer through the GoFree Shop, including without limitation our proprietary C-Map Genesis technology, GoFree Vessel, GoFree Telematics, GoFree Hooked, GoFree Link, BioBase and Insight Planner (the Site and these products and services will be referred to in this Privacy Policy as the "Service"). We want to develop relationships with our customers based on respect and integrity. We are aware of the trust and confidence you demonstrate when you access, visit or use the Service and provide us with information. This Privacy Policy is posted to demonstrate our commitment to protecting your privacy online. This Privacy Policy is part of, and is governed by, the terms and conditions set forth in the DMS Terms of Use located at http://www.genesismaps.com/Media/Terms_of_Use-CMAP_Genesis.pdf. Transactions and purchases made by you through the Site may be processed by our service provider C-MAP Italy S.r.l. located at Centro Direzionale Olidor Via Dorsale 9 - Scala B 54100 Massa ITALY. Please review Section 4(A) below in order to learn more about how we share your information with service providers like C-MAP.

By clicking the "accept" button when you register to use the Service, and by subsequently accessing, visiting and using the Service, you agree to accept the practices described in this Privacy Policy and consent to the collection, use and disclosure of personal information described in this Privacy Policy, including the use of cookies to collect information about you. If you do not agree to the terms of this Privacy Policy, please do not use the Service. We reserve the right to modify this Privacy Policy at any time, so each time you use the Service, you should check the date of this Privacy Policy (which appears above) and review any changes that have been made since your last visit to or use of the Service. Where appropriate or as required by applicable law, we shall notify you of any changes to this Privacy Policy.

1. **Information Collection.** The information described in this Section 1 is collected by Company through the Service. By using the Service, you expressly agree to the collection and use of the information described below.

A. Information We Directly Collect From You: We collect the following types of personal information (collectively, "Personal Information") that you voluntarily provide to Company through your use of the Service:

- Personal Identifiers. A "Personal Identifier" is information that can be used to identify and/or contact a natural person and includes, but is not limited to, name, postal address, telephone number, or email address.
- Other Personal Information. "Other Personal Information" is information combined with Personal Identifiers that may include your country of residence, demographic information (for example, gender or age), purchases made through the Site, credit card information or purchase history, correspondence sent to us through the Service or information regarding your tastes and preferences. In addition, if you register with the Service, you will be required to create a unique user ID and password which will be associated with your Personal Identifiers.

- Surveys. From time to time we may conduct surveys in respect of our products and services. Participation in our surveys is optional. However, if you respond to one of our surveys, we may ask you for information such as what type of boat you own, what your experience is with marine electronics, whether you prefer saltwater or freshwater boating and about other preferences that you might have. We will use this information to operate and improve the Service and to determine the types of offers, products or services that may be of interest to you.

If you do not provide us with the information we request from you, we may not be able to provide you with the products or services we offer through the Service.

C. Information That We Automatically Collect From Your Computer: We (or service providers on our behalf) may automatically collect information from you using “session cookies.” Session cookies are small amounts of data that are temporarily stored within your computer’s Internet browser while accessing our Site.

Information collected by session cookies may include, without limitation:

- the pages you visit within the Service;
- the date and time of your visit to the Service;

- the Internet Protocol (IP) address used to connect your computer to the Internet;
- your computer and connection information such as your browser type and version, browser language, operating system and platform; and/or
- your purchase history.

We will use data gathered using session cookies to help us improve your experience of the Service. You can set your browser to reject cookies or to notify you when you are sent a cookie. - Vessel data, including vessel location, vessel tracking history, vessel alarm notices, engine running data and engine alert data
- Digital photographs that you upload, post, create, use or access through the Service
- Product reviews you post on the Service – Any review that you post may be viewed by other users of the Service. If you elect to post a review we recommend that you do not post any Personal Information or other information that you do not want to make publicly available. **You are solely responsible for any loss of privacy or other harm resulting from the content you post on the Service.**
- Additional information may be collected by the Service as Company updates and releases new products and services or as you elect to use such products and services.

5. **Sharing of Personal Information with Third Parties.** Except as expressly provided in this Privacy Policy, we will not share, rent, sell or otherwise disclose your Personal Information to unrelated or unaffiliated third parties without your consent.

A. Service Providers: We may employ other companies or individuals and their affiliates, contractors, suppliers, agents and employees ("Service Providers") to provide certain services to us or on our behalf, such as operating and supporting the Service, processing payments and fulfilling orders you place through the Service, analyzing data, or performing marketing or consulting services. These Service Providers will only have access to the information needed to perform these limited functions on our behalf and are required to provide your Personal Information with at least the same level of protection and security as we use on the Service. 6. **Additional Privacy Protections for Children Using the Internet.** The Service is intended for a general audience and is not directed to children under the age of 18 or persons who are below the age of majority in any country. We will never knowingly collect Personal Information from children under the age of 18 or persons who are below the age of majority without verifiable parental consent. If you are under the age of 18 or are below the age of majority in your country, please do not provide us with Personal Information of any kind whatsoever. 10. **Closing Your Account; Retention of Personal Information.** Upon your request, we will close your account. We reserve the right to close or deactivate inactive accounts or accounts that are used in violation of our Terms of Use or any applicable law. We will retain Personal Information from closed or inactive accounts to the extent and as long as it is necessary and relevant for our operations and to comply with law, prevent fraud, collect any fees owed, resolve disputes, troubleshoot problems, assist with any investigations, enforce our Terms of Use, and take other actions otherwise permitted by law. In general, personal information from closed or inactive accounts will be deleted or anonymized two (2) years after the account is closed or deactivated unless we have grounds to believe that the Personal Information should be retained for one of the purposes identified above.

12. **Business Transfer.** In the event that the Company is sold, has its assets acquired or transferred, whether voluntarily or involuntarily, or merges or becomes affiliated with any other division, individual or entity, any customer information owned or under the control of the Company may be one of the transferred assets. Except as prohibited by applicable law, we reserve the right, as part of such transaction, to transfer or assign the Personal Information and other information we have collected from users of the Service.
13. **Use of Information Outside of Your Country of Residence.** When you use the Service, your personal information may be collected, transferred, stored, processed, or otherwise used outside of your country of residence, including, for residents of European countries, outside the European Economic Area (“EEA”).
